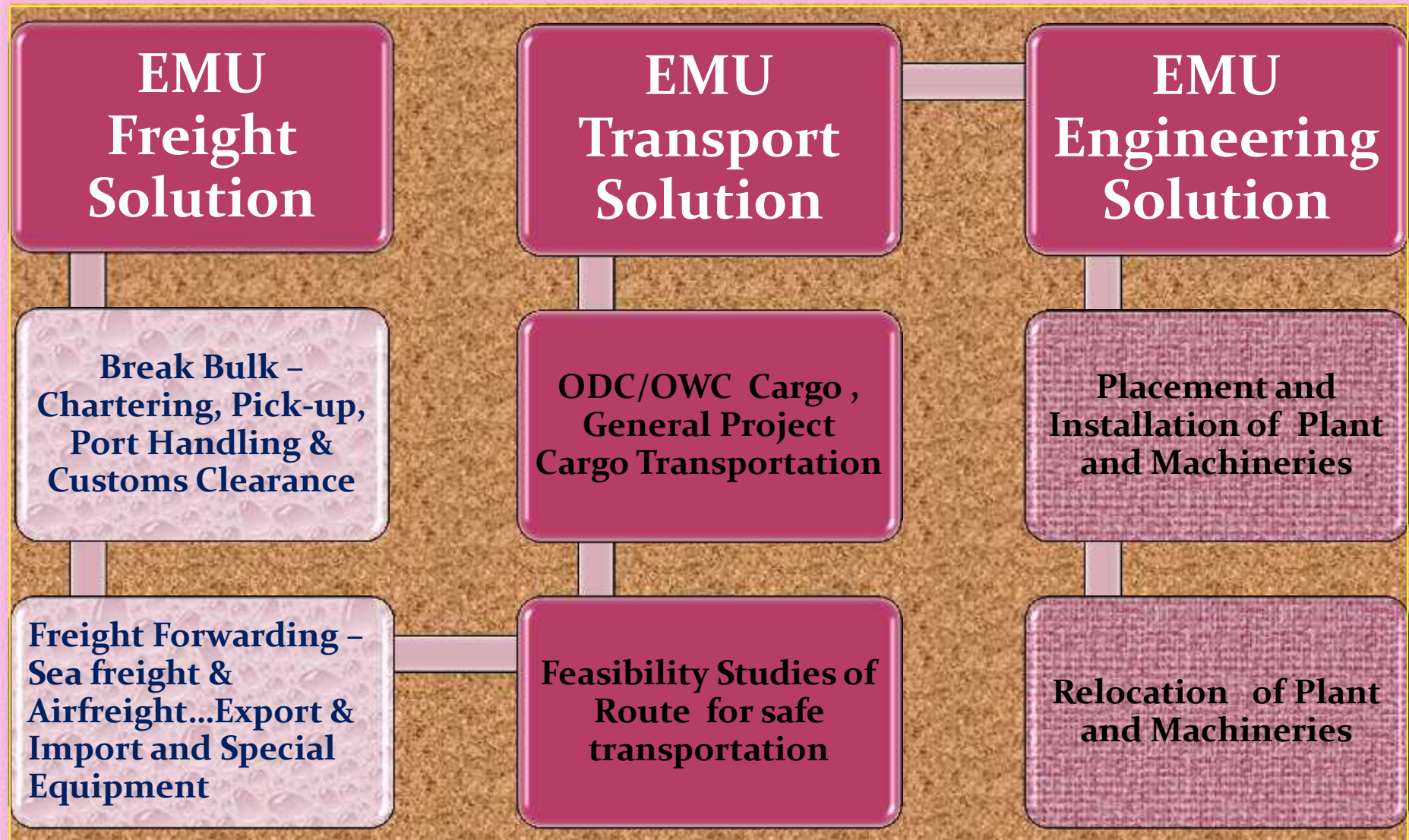

HEALTH, SAFETY AND ENVIRONMENT (HSE) POLICY


